- e. Approval of Anti-Crime & Nuisance Lighting Project: Partner with block clubs, LAPD and other community organizations to identify nuisance locations for the installation of DWP lighting. Lighting will deter crime by providing light sufficient to identify individuals at night thus reducing anonymity and comfort level of would-be criminals in dark areas.
  - i. Asset under the control of DWP
  - ii. Program Administered jointly by Public Safety Committee and City Services Committee
  - iii. Purchase and installation to take place ASAP after location is identified.
  - iv. COST: \$35 per light per month X 12 months. \$420 per light each year pre-paid.
  - v. Entire project for ECNANDC area shall not exceed 20 lights. \$8400 per year.
