### V. COMMUNITY/GOVERNMENT REPORTS & ANNOUNCEMENTS:

- Office of Mayor Eric Garcetti – David Price - Not Present
- LAPD Senior Lead Officers – Southwest SLO Representative, Officer Miller, introduced himself. Officer Miller reported that within the 3A19 NANDC area there have been 51 part 1 crimes w/in past 4 weeks which include Assault w/Deadly Weapon, Burglaries from Motor Vehicles, Burglaries, Grand Theft Auto, and Robberies. 3A57 area has had 49 Part 1 crimes. Grand Theft Auto crimes have been mostly on 23rd street between Figueroa & Hoover. There has been one Officer Involve Shooting at 22nd and Vermont involving 3 suspects, which were taken into custody without incident. He spoke about the community relations building through the Community Relations Office who have been reaching out to the community. They have been passing out about 2500 flyers informing community members about fireworks, resources, food distributions/giveaways, etc. He spoke about 311 & 911 services, and also about Crime Stoppers to report crimes anonymously. Crime Stoppers has a link @ Crime Stoppers. Limited police reports can now be filed on line at LAPD online.
- USC Public Safety Officers - Not Present
- Council District 1 for Councilmember Gil Cedillo – Ricardo Flores - Not Present
- Council District 8 for Councilmember Marqueece Harris-Dawson – Albizael Del Valle introduced himself to everyone. He spoke about the expansion of outside sit-down for restaurant owners. Within the NANDC area South LA Cafe, Caveman Kitchen, Mariscos Maria have permits which will be valid until September. CD 8 is planning another anti-body testing soon, CD 8 welcomes everyone. The anti-body test will be free. Albi spoke about the Planning Meeting with Building and Safety.
- Council District 9 for Councilmember Curren Price – Nora Gutierrez - LADOT still working with community members, will not ticket vehicles in community areas until mid August 2020. CD 9 has been doing food distributions; Nora will send information on upcoming food distributions. CD 9 has introduced City Council File Motions. Nora reminded everyone to try to get tested for COVID-19.
- The Office of Assemblymember Reggie Jones-Sawyer, Assembly District 59-Not Present
- The Office of Senator Holly Mitchell has partnered with St. Johns & LAUSD. They are doing testing every Friday at 118th Elementary School. You can make an appointment at (213) 400-0552. EDD issues were addressed especially with unemployment. If anyone needs assistance with unemployment please call the office number (213) 745-6656 (Senator Mitchell's Office is working from home). They will assist with EDD unemployment benefits.
- USC Community Report – Steve Wesson, USC Village Ombudsman, thanked everyone for their leadership. Thanked NANDC for their sponsorship with USC Blood Drive scheduled on July 22nd (Galen Center) and July 23rd (University Village). Flyer will be forwarded to NANDC. Their goal is 350 units of blood over the 2 day period. Regional Food Bank, St. Agnes and USC they have been able to put on 200 thousand pounds of food surrounding USC area and St. Agnes area. Vegetables/fresh produce, cheese/dairy, and grains/rice. Seeking additional volunteers to assist for future food distribution. Would like to thank the Burg/Creighton family for always answering the call when needed
- Department of Neighborhood Empowerment (DONE) – Karen Hernandez shared that NANDC's By-Laws were approved. She spoke about funding training expiration extensions for another 60 days. If anyone needs assistance with Cornerstone Log-in information please reach out to her or Rosters@lacity.org.

### VI. PRESENTATIONS & REPORTS

- Crosstown LA** – Gabriel Kahn, Crosstown LA Editor, gave area crime report within the NANDC area. He concurred with Officer Miller's data. He also stated that vehicle thefts have been on a rise. Gabriel also gave a COVID-19 statistics report, where unfortunately EXPO area has one of the highest numbers in cases. All this information can be seen on NANDC's website and Crosstown LA website. Crosstown LA is also working on air quality data.

- b. South Los Angeles Alliance of Neighborhood Councils** – Thryeris Mason, SLAANC Chair, gave a recap of SLAANC's June Conversations. One of the conversation was with Capri Maddox who is heading the department of human civil rights. She will be investigating housing, employment, and education issues. SLAANC also had a conversation with Deputy Chief Regina Scott & Captain Billy Brockway. They both spoke about things LAPD has adopted, if anyone would like full detail please email President Mason @ [president@nandc.org](mailto:president@nandc.org). Deputy Regina Scott is in agreement of defunding the police too.
- c. NANDC Food Giveaway Update** – Julianne Burg, Vice President & Marco Flores, Area 1 Representative gave an update on NANDC's Food Giveaway scheduled for August 15, 2020 at St. Marks Church (Vermont & 36th Street). NANDC will purchase 285 food boxes from South LA Cafe.
- d. NANDC PSA & NANDC Nods Update** -- Steve Pepjdonovic, Marketing & Outreach Chair, gave an update on the PSA & NANDC Nods update. NANDC is looking for a PSA within the medical field to speak on the COVID-19 pandemic. Soliciting NANDC Nods to recognize essential workers in our community, anyone putting their selves at risk (Mailman/Mailwomen, grocery workers, store workers, etc.)
- e. NANDC Policy Committee Update** – Jean Frost, Policy Committee Chair, informed everyone that they met on June 23rd. The biggest topic was regarding the AAA development. Jean invited everyone to attend July's policy committee meeting to continue the dialogue about the AAA development.
- f. Area 2 Vacancy** – Thryeris Mason, President announced one (1) seat for Area 2 which is now open for stakeholder applications and consideration at our August General Board Meeting. Per Article (V)(1)(b), B. Appointed Positions: A Candidate's application for appointment seat on the Governing Board shall include: (i) Letter from the applicant describing the value they would add to the community as a member of the governing board, indicating a willingness to serve their designated term, and accepting responsibilities of the office. (ii) Petition signed by a minimum of fifteen (15) stakeholders in support of the application. Signatures shall include name, address, and, where possible, e-mail address for each stakeholder. The public is requested to fill out a “Speaker Card” to address the Board on any agenda item before the Board takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the Board’s jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to 2 minutes per speaker, unless adjusted by the presiding officer of the Board.

**RALPH M. BROWN ACT**

54954.2. (a) At least 72 hours before a regular meeting, the legislative body of the local agency, or its designee, shall post an agenda containing a brief general description of each item of business to be transacted or discussed at the meeting, including items to be discussed in closed session. A brief general description of an item generally need not exceed 20 words. The agenda shall specify the time and location of the regular meeting and shall be posted in a

location that is freely accessible to members of the public. If requested, the agenda shall be made available in appropriate alternative formats to persons with a disability, as required by Section 202 of the Americans with Disabilities Act of 1990 (42 U.S.C. Sec. 12132), and the federal rules and regulations adopted in implementation thereof. The agenda shall include information regarding how, to whom, and when a request for disability-related modification or accommodation, including auxiliary aids or services may be made by a person with a disability who requires a modification or accommodation in order to participate in the public meeting.

### **REMOVAL WARNING**

In the event that any meeting is willfully interrupted by a group or groups of persons so as to render the orderly conduct of such meeting unfeasible and order cannot be restored by the removal of individuals who are willfully interrupting the meeting, the members of the legislative body conducting the meeting may order the meeting room cleared and continue in session. Only matters appearing on the agenda may be considered in such a session. Representatives of the press or other news media, except those participating in the disturbance, shall be allowed to attend any session held pursuant to this section. Nothing in this section shall prohibit the legislative body from establishing a procedure for readmitting an individual or individuals not responsible for willfully disturbing the orderly conduct of the meeting.

Government code Section 54957.9

### **DISRUPTION OF MEETINGS**

Any person who interferes with the conduct of a Neighborhood Council meeting by willfully interrupting and/or disrupting the meeting is subject to removal. A Peace Officer may be requested to assist with the removal by the Neighborhood Council.

Any person who resists removal by a Peace Officer is subject to arrest and prosecution.
