LOS ANGELES SOCIAL EQUITY PROGRAM

CANNABIS CRIMINALIZATION AND ITS ENFORCEMENT HAS HAD LONG TERM, ADVERSE IMPACTS TO THE CITY OF LOS ANGELES, PARTICULARLY FOR LOW INCOME AND MINORITY COMMUNITY MEMBERS.



Dear Colleagues,

As public servants of the City of Los Angeles, we are committed to building a just, equitable, and thriving city. Together, with the residents we serve, we embark on a historic process to construct the framework of a new industry. Facilitating the nation's most lucrative commercial cannabis market which may dramatically reshape the landscape of our city.

Even as we stand on this precipice, we must recognize that we stand squarely in the shadow of the unjust War on Drugs. This atrocity targeted Angelinos of color, decimated neighborhoods, ripped families apart, and criminalized the illness of addiction. Today, we have an opportunity to build new systems and shape an industry in ways that recognizes wrongs, respect all residents, and intentionally builds a more equitable society.

THE WAR ON DRUGS

Beginning in 1971, President Nixon declared drugs as one the biggest existential threats to the United States. This declaration set us on a failed path to spend over one trillion dollars, arrest over 40 million people, and destroy countless families and neighborhoods, particularly in communities of color. Experts agree, this War disproportionately targeted black and Latino families. Today, 80 percent of people federally incarcerated for drug offenses are black or Latino 2

Angelinos are not exempt from these racially-biased practices. Despite the reality that black young people use cannabis and lower rates than and white young people, black Angelinos are

The War on Drugs has exacted a punishing burden on communities of color, both within the City of Los Angeles and across the country. With the legalization of recreational marijuana in California in November 2016, we celebrate the opportunity to move the target of enforcing drug laws to more appropriate and beneficial ends. The support of Proposition M on March 7, 2017 grants the City authority to regulate and tax all aspects of commercial cannabis activity.

MOTION

While we expect the majority of the 7% Cannabis Systems Development Surcharge revenue to be directed toward the administration of cannabis regulation-including in the Finance, ITA, City Attorney, Police and Fire Departments, City Administrator, Building and Safety offices-it is equally important to improve the health outcomes of our minority communities as they recover from pernicious drug laws.

Through the new cannabis tax revenue, the City should create a Neighborhood Health Fund that offers small grants to programs that (1) improve resident life outcomes and (2) address the roots of prevention and healthy communities in Tier 1 and Tier 2 zones. These programs can include youth leadership and civic engagement, after-school, and educational opportunities, as well as improved local health services. The Neighborhood Health Fund should incentivize the participation of Community Benefit Organizations (CBO) in outreach programs, and give partners matching grants that can be used toward broader Neighborhood Health efforts, such as youth leadership and development. This program should explicitly target Tier 1 and 2 zones as a strategy to revitalize communities damaged by the war on drugs.

I THEREFORE MOVE that the City Administrative Officer, with the assistance of the Chief Legislative Analyst, the City Attorney and other appropriate departments be directed to report on the financial feasibility of establishing a Neighborhood Health Fund and other Community Benefit type programming to combat the effects of the War on Drugs and improve the health outcomes for our communities of color.

CANNABIS REGULATION SPECIAL REVENNUE TRUST FUND

Section 5.586 of the Los Angeles Administrative Code (LAAC) establishes the Department of Cannabis Regulation Cannabis Regulation Trust Fund. This fund receives monies from fees paid for the licensing and permitting of new and existing cannabis retailers, cultivators, distributors, and manufacturers in the City of Los Angeles pursuant to Chapter 10, Articles 4 and 5 of the Los Angeles Municipal Code (LAMC). The Fund is administered by the Department of Cannabis Regulation to pay salaries, expenses, equipment, materials, and services in support of the Department's functions relating to those services for which fees are paid into the Fund.


